

**Description:** This Cookie Policy explains what cookies are, how and why Agentoverse uses them on its Platform, and what choices you have regarding cookies. We use third-party cookies on the Platform, specifically Google Analytics and Google Ads, to monitor website traffic and user behavior. This information helps us optimize functionality and improve our services. For details on how Google processes data, please refer to their Privacy Policy: <https://policies.google.com/privacy>. Users have the option to set their preferences regarding the use of these cookies upon their first visit to the website.

## What Are Cookies?

Cookies are small text files that are stored on your device (computer, smartphone, etc.) by websites that you visit. They are widely used to make websites work or work more efficiently, as well as to provide information to the site owners. Cookies can have various purposes: some are necessary for a website's technical operation, and others may be used for analytics, preferences, or advertising.

There are different types of cookies:

- **Session Cookies:** Temporary cookies that remain in your browser's cookie file until you leave the website. They are deleted once you close your browser. These are often used for essential site functions (e.g., keeping you logged in during your session).
- **Persistent Cookies:** Cookies that remain stored on your device for a longer period or until you delete them. They help websites remember your settings or identify you upon return (e.g., language preference).
- **First-party Cookies:** Cookies set by the website you are visiting (in this case, Agentoverse).
- **Third-party Cookies:** Cookies set by a domain different from the site you are visiting, often used for cross-site tracking, analytics, or advertising.

## How We Use Cookies

At present, Agentoverse uses cookies in a very limited manner, primarily to ensure the functionality and security of the Platform:

- **Essential Cookies (Necessary):** These cookies are required for the operation of the Platform. For example, when you log in to your Agentoverse account, we set a cookie to maintain your session so that you stay logged in as you navigate the site. Essential cookies may also be used to remember certain choices you make (such as your language preference) or to safeguard security (such as to authenticate requests or prevent cross-site request forgery).

*These cookies are first-party cookies and are used solely by us. Because they are*

*necessary for the provision of the service you request, they do not require your consent under applicable law.*

- **Analytics Cookies:** *None at this time.* We do **not** use Google Analytics or similar analytics cookies that track your usage across sessions. We currently do not collect analytical data via cookies. Any usage analysis we perform is done on an aggregated basis using server logs or similar, without tracking individual user behavior via cookies.
- **Advertising Cookies:** *None at this time.* Agentoverse does not serve ads and does not use advertising or marketing cookies on the Platform. You will not find cookies for advertising networks or social media on our site.
- **Third-Party Cookies:** Our Platform does not presently utilize any third-party cookies or trackers. All cookies used are set by Agentoverse (first-party). If we embed content from third parties in the future (for example, a YouTube video or other widget), such third-party content could set cookies – but we currently have no such embeds on our site.

In summary, **the only cookies in use are those strictly necessary for the service** (authentication/session cookies and possibly preference cookies for things like language selection). We do not use cookies for any non-essential purposes at this time.

## Cookie List

For transparency, here are the cookies that may be set when using our Platform:

- **SessionID (Essential):** A unique identifier (random token) linking your browser to your logged-in session on our servers. Purpose: to keep you logged in as you move between pages, and to remember your login state. Expires: typically when you log out or shortly after you close your browser.
- **CSRF-Token (Essential):** A token that helps prevent cross-site request forgery attacks by confirming that actions performed on the site are intentionally made by you. Purpose: security. Expires: end of session.
- **CookiesConsent (Optional):** If we ever present a cookie consent banner and you make a choice, we would use a cookie to remember that preference. Currently not in use because we only use essential cookies.

*(Note: The above are examples and may vary. We will update this list if we introduce any new cookies.)*

## Managing Cookies

Most web browsers automatically accept cookies, but you have the ability to accept, decline, or delete cookies through your browser settings. The method for doing so varies by browser (Chrome, Firefox, Safari, Edge, etc.), so you should check your browser's help or support pages for instructions on deleting or disabling cookies.

Be aware that if you disable cookies entirely, the Platform may not function properly for you:

- If you block essential cookies, you might not be able to log in or stay logged in, or some features might not work as intended.

Since we currently do not use any non-essential cookies, we do not provide an in-platform cookie settings manager at this time. If our use of cookies changes in the future (for example, if we introduce analytics or similar cookies), we will implement appropriate consent mechanisms in accordance with the law (e.g., a cookie consent banner where required) and update this Cookie Policy to reflect the changes.

## Future Changes and Consent

Because our Platform **does not presently use any cookies requiring consent**, we operate under the assumption that your continued use of our site implies consent to the minimal cookies that are necessary for its operation. Should we decide to add new categories of cookies (such as analytics or third-party tools) in the future:

- We will update our Cookie Policy to detail those cookies and their purpose.
- If required by law, we will seek your consent before placing non-essential cookies on your device. This may be done via a cookie consent banner or pop-up when you visit our site.
- You will always have the opportunity to opt in or out of non-essential cookies.

We are committed to being transparent about our cookie practices. The date of the latest update to this Cookie Policy is indicated at the top of this section/document.
